ENTRY INFORMATION: All entries & fees must be received by Monday July 23rd by 5 PM. Starting times will be available on July 26th after 12 PM. Call Marci at 615/390-4218. If you give an email address, every effort will be made to email starting times as well.

RULES: USAR rules apply. USAR membership IS NOT REQUIRED. All divisions will be "shootout" style or round robin play. USAR approved eyewear is mandatory. All matches are self-refereed.
